Dear Parent/Legal Guardian,

According to board policy, non-school owned and/or prescription medication may not be administered at school without a **current** (yearly) written order. Therefore, we have attached the 2019-20 Medication Order and Consent form for your convenience. **The authorized prescriber/primary care provider's section must be completed and signed by your student's authorized prescriber/primary care provider** if any non-school owned or prescription medication is to be administered to the student while at school. Non-school owned and/or prescription medication will not be administered without a written authorized prescriber/primary care provider's order and written consent from the parent/legal guardian. This includes prescription, non-prescription and school-owned medication. Please print clearly when completing this form. Incomplete and illegible forms may be returned. Completed forms will be accepted at the school during regular office hours.

Providing for the safety and well-being of all students is our highest priority. In accordance with board policy, **students may not carry on their person, or transport on school buses, any form of medication.** A parent/legal guardian must deliver/pick-up medications at the school nurse's office. Medications must be in their original container, labeled with the student's name, the authorized prescriber/primary care provider's name, and the name and telephone number of the pharmacy distributing the medication. Please contact the school nurse's office for further information.

All children in Missouri must be immunized according to state guidelines **before** attending school, unless medically or religiously exempt from an immunization. This requirement applies to "booster" immunizations as well. Documentation must be provided to the nurse before starting classes on Aug. 14.

The required immunization schedule may be obtained from your authorized prescriber/primary care provider, county health department, or the internet at <https://health.mo.gov/living/wellness/immunizations/pdf/1920schoolrequirements.pdf> to assist you in determining if your child is in need of immunizations prior to the beginning of school in August. Required immunizations should be completed prior to attending school. Written documentation of immunizations received throughout the summer will be required for school attendance. If immunizations are not required, please be prepared to present a notarized exemption card from your child's authorized prescriber/primary care provider, to the nurse's office to keep on file.
